

Privacy Policy

IMPORTANT NOTICE: Our Services are hosted in the United States and intended ONLY for visitors located within the United States. If you choose to use the Services from the European Union or other regions of the world with laws governing data collection and use that may differ from U.S. law, then please note that you are transferring your personal information outside of those regions to the U.S. for storage, use, and processing. By providing us any information, including your Personal Information, you consent to such transfer, storage, and processing.

We at Inflection Medicine, Inc. (“Inflection,” “we,” “us,” or “our”) value your privacy, and we provide this Privacy Policy to describe the information we collect, how we use it, when and to whom we disclose it, and your rights regarding collection, use, access, and how to update and correct your Personal Information. This Privacy Policy applies to our publicly-available website and all other Personal Information collected offline, as well as online services on which we display a link to this Privacy Policy (collectively, the “Inflection Website”).

By accessing or using the Inflection Website or otherwise providing us with information about you, you agree to this Privacy Policy. If you do not agree to this Privacy Policy, please do not access or use the Inflection Website or provide us with information.

1. What We May Collect:

We collect information relating to you (“Personal Information”) when you use the Inflection Website, interact with us through your interaction with the Inflection Website, and from other parties. Personal Information we collect may include:

Account Information: If/when you create an account with us, we may collect information associated with your account, including your name, contact information, account credentials.

Communication Information: If you communicate with us, we may collect information such as your name, contact information, and the contents of any messages you send.

Technical Information: We, or our third-party providers, may also collect device identifiers, IP Addresses, http referrer fields, and other information about your computer or device and your usage of the Inflection Website. We may also collect information that is sent to us automatically by your web browser. We automatically receive information about your interactions with the Inflection Website, such as the pages or other content you view and the dates and times of your visits. We may also collect general location information (e.g. inferred from an IP address).

Other Information: We collect other information that you may provide to us, such as when you participate in our events, trials, or surveys or provide us with information to establish your identity.

Information from Cookies and Similar Technologies:

Inflection may use session cookies and persistent cookies for the purposes identified in this Privacy Policy, including to make interactions with us easy and meaningful. Session cookies exist during one session. They are engineered to disappear from your computer when you close your browser software or turn off your computer. Persistent cookies remain on your computer after you close your browser or turn off your computer. As we adopt additional technologies, we may also gather additional information through other methods.

Disabling Cookies and Similar Technologies: Most Web browsers automatically accept cookies, but your browser may allow you to modify your browser settings to decline cookies if you prefer. If you disable your

Web browser's ability to accept cookies, you may be unable to access some or all functionalities of the Inflection Website.

Cookies in Emails: We or our third-party vendors also may use certain of these technologies in emails to our customers or other email recipients to help us track email response rates, identify when our emails are viewed, and track whether our emails are forwarded.

Analytics: We may use a variety of online analytics products that use cookies and other tracking technologies for the purposes described in this Privacy Policy, including to help us analyze how users use the Inflection Website and so we might enhance your experience when you use the Inflection Website.

2. How We May Use Personal Information:

We may use Personal Information for the following purposes:

To provide, administer, maintain and/or analyze the Inflection Website or other services we may provide;

To improve the Inflection Website and conduct research;

To communicate with you, including to send you information about the Inflection Website and its features;

To develop new programs, products, models, and services;

To process transactions;

To prevent fraud, criminal activity, or misuse of the Inflection Website, and to protect the security of our IT systems, architecture, and networks;

To comply with legal obligations and legal process and to protect our rights, privacy, safety, or property, and/or that of our affiliates, you, or other third parties; and/or

To enroll in a clinical trial or to access patient support or recommendations or a patient support program (upon your consent).

3. When We Disclose the Information We Collect, We May Disclose Your Information to Others, Like:

To our affiliates, auditors, attorneys, or other authorized representatives.

In a manner we disclose to you that may require gaining your prior consent or for acting at your direction.

To third-party vendors that provide services to us, such as third-party hosting providers.

To identify and engage thought leaders, clinical, scientific, medical or other external experts.

For the performance of a contract with you (e.g., consulting; speaker agreement).

To facilitate recruitment activities, such as processing employment applications, evaluating a job candidate for an employment activity, negotiating employment contracts, and monitoring recruitment statistics.

To conduct other legitimate business activities, as allowed by applicable law.

If we believe in good faith that doing so is necessary or appropriate to protect or defend the rights, safety, or property of Inflection, our agents and affiliates, employees, users and/or the public, including to defend or enforce our Privacy Policy or any other contractual arrangement.

If we believe in good faith that doing so is necessary or appropriate to comply with any law enforcement, legal, or regulatory process, such as to respond to a warrant, subpoena, court order, or other applicable laws and regulations.

In connection with or during negotiations of any merger, sale of company assets, financing, or acquisition of all or a portion of our business to another company.

All the above categories exclude text messaging originator opt-in data and consent; this information will not be shared with any third parties.

We may combine the Personal Information we collect about you online with the personal information we collect about you from our offline interactions with you (for example, our interactions by telephone or in person). We may also combine any of the information we collect about you with information we lawfully obtain from other sources, such as public records or websites, or other third parties (e.g., health care professionals, patient groups, government agencies). If necessary, we will endeavor to gain your consent, or provide an opportunity for you to opt out of this type of activity, or you can opt out by going here info@inflectionmedicine.com.

4. Aggregated or De-Identified Information:

We may combine information that we collect from you through the Inflection Website with information that we obtain from affiliated and nonaffiliated third parties, and information derived from any other products or services we provide. We may also aggregate or de-identify Personal Information so that it may no longer be used to identify you and use such information to analyze the effectiveness of the Inflection Website, to improve and add features to the Inflection Website, to conduct research and for other similar purposes. In addition, from time to time, we may analyze the general behavior and characteristics of users of the Inflection Website and share aggregated information like general user statistics with third parties, publish such aggregated information or make such aggregated information generally available. We may collect aggregated information through the Inflection Website, through cookies, and through other means described in this Privacy Policy. We will maintain and use de-identified information in anonymous or de-identified form and we will not attempt to reidentify the information, unless required or authorized by law.

5. Online Analytics:

We may use third-party web analytics services on the Inflection Website, such as those of Google Analytics. These vendors use the sort of technology described in the “Personal information we collect” section above to help us analyze how users use the Inflection Website, including by noting the third-party website from which you arrive. The information collected by such technology will be disclosed to or collected directly by these vendors, who use the information to evaluate your use of the Inflection Website. We also use Google Analytics for certain purposes related to advertising, as described in the following section. To prevent Google Analytics from using your information for web analytics, you may install the Google Analytics Opt-Out Browser Add-on.

We may also allow third-party networks to place cookies or other tracking technologies on your computer, mobile phone, or other device to collect information about your use of the Inflection Website in order to (a) inform, optimize, and serve marketing or other promotional content based on past visits to our website and other online services and (b) report how our marketing content impressions and interactions with these marketing impressions are related to visits to our online services. We also allow other unaffiliated parties (e.g., ad networks and ad servers such as Google Analytics) to serve tailored marketing to you and to access their own cookies or other tracking technologies on your computer, mobile phone, or other device you use to access the Inflection Website. Those parties that use these technologies may offer you a way to opt out of targeted advertising as described below. You may receive tailored advertising on your computer through a web browser. Cookies may be associated with de-identified data linked to or derived from data you voluntarily have submitted to us (e.g., your email address) that we may disclose to a vendor in hashed, non-human-readable form.

6. Automated Decision-Making:

We process Personal Information using both manual and automated methods of processing. Automated methods are often used to assist our manual methods in accordance with applicable laws. Where an individual's rights and legitimate interests may be impacted by such automated decision-making, we will

provide the impacted individual the opportunity to inquire about the decision or request manual review. Manual review may be conducted by Inflection employees or trusted third-party business partners working on our behalf.

7. Your Rights Include:

Depending on location, you may have certain statutory rights in relation to your Personal Information. For example, you may have the right to:

Update certain of your information with Inflection.

Unsubscribe from promotional emails by following the directions in those emails.

Opt out of certain cookie-related and analytics processing by the following info@inflectionmedicine.com.

Obtain information about the categories of Personal Information we collect or disclose about you; the categories of sources of such information; the business or commercial purpose for collecting such information; and the categories of unaffiliated parties to whom we disclose such personal information. Such information is also set forth in this Privacy Policy.

Access your Personal Information and information relating to how it is processed.

Delete your Personal Information from our records.

Rectify or update your Personal Information.

Transfer your Personal Information to a third party (right to data portability).

Restrict how we process your Personal Information.

Withdraw your consent—where we rely on consent as the legal basis for processing.

Object to how we process your Personal Information.

Obtain information about the financial incentives we offer you, if any.

Lodge a complaint with your local data protection authority.

You also have the right to not be discriminated against (as provided for in applicable law) for exercising your rights.

Please note, however, that certain information may be exempt from such requests in some circumstances, which may include needing to continue processing your information for our legitimate interests or to comply with a legal obligation. If your information has been disclosed to an unaffiliated party at your direction, Inflection cannot delete or amend such disclosed information.

We may request you provide us with information necessary to confirm your identity before responding to your request. You can exercise some of these rights through us at this info@inflectionmedicine.com.

We may use third-party analytics services and online advertising services that may result in the “sharing” of online identifiers (e.g., cookie data, IP addresses, device identifiers, general location information, and usage information) with advertising partners to advertise the Inflection Website on other websites. If you or your authorized agent would like to opt out of our “sharing” of your information for such purposes, you may do so by using the tools described in the section above on “Online analytics and tailored advertising.”

We do not knowingly “sell” or “share” the personal information of children under 18.

All the above categories exclude text messaging originator opt-in data and consent; this information will not be shared with any third parties.

8. Exercising Your Rights:

Where you are given the option to share your personal information with us, you can always choose not to do so. You can also request the correction of your personal information or restrict or object to the processing of your personal information.

You are also entitled to request information regarding the personal data we collect and use at any time, you may also object to the further use of this information as well as request to modify the extent to which your Personal Information is used, that the information be corrected, or that the information be deleted altogether. Please note that we may only delete your Personal Information in the event that no legal requirements to the contrary exist, or which require this information to be stored, or in the event that where the right to store this information does not take precedence over your right to have it deleted. Please also note that once you have requested to have your information deleted, or to have the use of your information limited, or you have objected to the processing of your information, you may then no longer be able to use our services, to the extent our services require the use of your personal information.

If your personal information is being used by us because you have agreed to have it used, or because it is required for the fulfilment of a contract you have concluded with Inflection, you may request a copy of the information that you have made available to us. Please send your request using the contact information found in Section 16 at the end of this Privacy Policy. Be sure to include which data or processing activities you are requesting information about, in what format you would like to receive this information, and whether the information should be sent to you or another recipient. Inflection will carefully review your request and inform you of the best way it may be fulfilled.

If you object to the processing of your personal information, or if you have provided your consent to processing and you later choose to withdraw it, we will respect that choice in accordance with our legal obligations. This could however mean that we may not be able to perform the actions necessary to achieve the purposes as set out in this policy.

Verification. In order to protect your Personal Information from unauthorized access, change, or deletion, we may require you to verify your credentials before you can submit a request to know, correct, or delete Personal Information. If you do not have an account with us, or if we suspect fraudulent or malicious activity, we may ask you to provide additional Personal Information and proof of residency for verification. If we cannot verify your identity, we will not be able to honor your request.

Authorized Agents. You may also submit a rights request through an authorized agent. If you do so, the agent must present signed written permission to act on your behalf and you may also be required to independently verify your identity and submit proof of your residency with us. 9. Children's Privacy:

The Inflection Website is intended for users over the age of 18. We encourage parents and guardians to take an active role in their children's online activities. We will not knowingly collect Personal Data from individuals under the age of 18 or under without appropriate parental or guardian consent. 10. Do Not Track:

We do not respond to browser-initiated Do Not Track signals, as the internet industry is currently still working on Do Not Track standards, implementations, and solutions.

11. Links to Other Websites:

The Inflection Website may contain links to other websites not operated or controlled by Inflection, including social media services (“Third Party Sites”). The information that you share with Third Party Sites will be governed by the specific privacy policies and terms of service of the Third Party Sites and not by this Privacy Policy. By providing these links we do not imply that we endorse or have reviewed these sites. Please contact the Third Party Sites directly for information on their privacy practices and policies.

12. Security and Retention:

We implement technical, administrative, and organizational measures to protect Personal Information both online and offline from loss, misuse, and unauthorized access, disclosure, alteration, or destruction. However, no Internet or email transmission is ever fully secure or error free. In particular, email sent to or from us may not be secure. Therefore, you should take special care in deciding what information you send to us via the Inflection Website or email. In addition, we are not responsible for circumvention of any privacy settings or security measures contained on the Inflection Website, or third-party websites. We’ll retain your Personal Information for only as long as we need in order to provide our Inflection Website to you, or for other legitimate business purposes such as resolving disputes, safety and security reasons, or complying with our legal obligations. How long we retain Personal Information will depend on a number of factors, such as the amount, nature, and sensitivity of the information, the potential risk of harm from unauthorized use or disclosure, our purpose for processing the information, and any legal requirements.

13. Updates to this Privacy Policy:

We may update this Privacy Policy from time to time. If we modify our Privacy Policy, we will post the revised version here with an updated revision date. If we make material changes to our Privacy Policy, we may also notify you by other means, such as by posting a notice on our websites or sending you a notification. By continuing to use our website after such revisions are in effect, you accept and agree to the revisions and to abide by them.
